Discussion on the noise ordinance was conducted, and the following is some of what was discussed:

Norman Cowden wanted clarification on why the noise ordinance that we have today was not able to be enforced. The Solicitor did state that the ordinance that the borough has today is enforceable, but the council can make changes or additions if they feel they would like to. John McCormick also wanted to ask if the ordinance was enforceable.

Norman Cowden asked the borough manager why the police could not enforce the ordinance that we have currently. The Borough Manager advised that the police will enforce the ordinance if they are contacted. The noise complaint must be given to the police as the issue is happening and the police will go and investigate and enforce if they need to. The police department advised that they have addressed noise complaints in the borough.

The council received documentation in the previous meetings from the borough manager as well as resident Kathy Wither on noise issues and information from PLCB. The Borough Manager also included additional documentation for the council with examples of other ordinances and entertainment district rules and regulations permitting outdoor music/. entertainment and articles that other areas have had to address noise complaints from commercial businesses with outdoor music.

Katie Caputo was not at meeting for the public comment period so the President permitted her to speak, and she again expressed her concern for the noise from the outdoor parties Music/Bands playing music outside at the VFW under the pavilion and expressed that she hoped council would take her family in consideration when making a decision on the noise ordinance. The Pavillion area is for picnics not Live Music. She is asking that the council is mindful of the PLCB state laws to not make our ordinance overseed the state.

Shawn Millard wanted to express his thoughts on setting time limits on amplified music outside. Discussed the decibels and the footage that you can hear amplified music.

Attorney suggested that the council should be careful to add decibels but that adding amplified music restrictions could be made.

Paul McKinley Winter Street wants to keep the ordinance the same but said look at the business district only not the entire borough. He suggested the VFW put up a privacy fence to help block the noise. He is worried about the residents not being able to enjoy music in their own yard. Discussion on the outdoor entertainment vs noise.

John McCormick asked the residents in attendance what would work for them. What compromise could the council do for them and the VFW. He stated that the commander of the VFW did admit that some of the bands were loud, and they were not having them back this year. John stated that maybe we should wait to see how the commander is going to fix the issue as he advised us in the earlier meetings that he wants to be a good neighbor and work with keeping noise level down.

Kathy Wither wanted to make sure that the council was making ordinance stricter than state PLCB

The solicitor explained what unreasonable nuisance would be. Complaints of noise must be sent to the police as a complaint so that they can effectively enforce.

Motion #3 was moved and seconded (Shawn Millard/Dori Rankinen) to approve the changes to the existing ordinance that amplified music heard 75 feet beyond property line between the hours of 9pm to 8am is presumed to be unreasonable and a nuisance and advertise for the February meeting approval of the addition to the current noise ordinance.
