ALL TAXES ARE DUE BY DECEMBER 31, 2024, POSTMARK AND DROP BOX COUNT FOR DUE DATES IF YOUR TAXES ARE INCLUDED IN YOUR MORTGAGE, FORWARD THE ORIGINAL BILL TO YOUR MORTGAGE COMPANY IMMEDIATELY. FAILURE TO FORWARD THE ORIGINAL BILL COULD RESULT IN A DELAY AND/OR FEE CHARGED.

KEEP A COPY OF THE BILL FOR YOUR RECORDS. IF YOU WOULD LIKE A PAID RECEIPT ENCLOSE A SELF ADDRESSED STAMPED ENVELOPE WITH THE PAYMENT AND BILL. A RECEIPT IS RECOMMENDED IF YOU ITEMIZE YOUR TAXES, OR PLAN ON SELLING OR RE-FINANCING YOUR PROPERTY IN THE NEAR FUTURE. ALSO A RECEIPT CONFIRMS MY OFFICE RECEIVED YOUR PAYMENT.

IF YOUR **PERMANENT ADDRESS** ON YOUR TAX NOTICE IS INCORRECT, PLEASE CALL THE COUNTY ASSESSMENT OFFICE AT (570) 327-2301. THEIR OFFICE IS RESPONSIBLE FOR THE ADDRESSES ON THE TAX PARCELS. FAILURE TO RECEIVE A TAX BILL DOES NOT ELIMINATE THE TAX OR CHANGE ANY DUE DATES. IT IS TO YOUR BENEFIT TO RECEIVE THE TAX BILL CORRECTLY.

PENNSYLVANIA PROPERTY TAX REBATE PROGRAM (FOR SENIORS)

IF YOU ARE

- 65 OR OLDER – OR A WIDOW/WIDOWER AGE 50 OR OLDER OR DISABLED AND 18 OR OLDER AND
- EARN LESS THAN 45,000 A YEAR (YOU CAN EXCLUDE ½ OF SOCIAL SECURITY INCOME)
- AND OWN YOUR OWN HOME (DEED IN YOUR NAME)

YOU MAY BE ELIGIBLE FOR A REBATE
